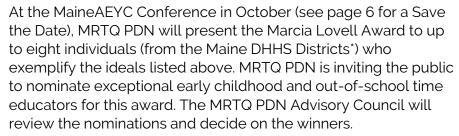

### Seeking Nominations for the 2018 Marcia Lovell Awards

MRTQ PDN created the Marcia Lovell Award for Innovation in Early Care and Education to recognize outstanding early childhood and out-of-school time professionals who make significant contributions to the children, families, and

communities in which they work and embody the ideals for which Marcia advocated:

- Better lives for children:
- High-quality early education experiences;
- Support for all children, including those most at risk and with disabilities;
- And the belief that the arts are an integral part of early education programs.



Nominations must meet the following criteria:

- They must describe a practitioner in a child care center, family child care, out-of-school time program, Head Start, public preschool program, or nursery school in Maine.
- The nominee must be a member of the MRTQ Registry.
- A complete nomination form must be received by September 19, 2018.

### Changes to MRTQ PDN Training Schedule

MRTQ PDN has made the following changes to the way we announce our training schedule:

- Training registration now opens twice each year, which is a change from the previous quarterly schedule. The new schedule is:
  - o **December 1**st Registration open for training beginning January 1st - June 30th
  - **June 1st –** Registration open for training beginning July 1st - December 31st

### New FREE Resource from MRTQ PDN: Quality Improvement Toolkits (QITs)

MRTQ PDN is excited to announce the statewide launch of a new, free professional development resource: the Quality Improvement Toolkits (QITs). With generous funding from the Davis Family Foundation, MRTQ PDN created four self-paced, on-demand, online QITs addressing the following topics:

- Program evaluation
- Professional development planning
- Assessment of child progress
- Creating a curriculum framework

The QITs will be available through the MRTQ PDN website beginning in September. Watch for an announcement in SHORTcuts

### How do the QITs work?

Anyone can access the QITs online. There is a quick self-enrollment process where you will provide an email address (that will not be shared). There is a brief introductory module that explains the QITs and how to use them, then you can proceed in any order and at whatever pace works best for you.

#### What types of programs will benefit from the QITs?

Family child care programs, center-based programs, out-of-school time programs, public preschool programs, nursery schools, and Head Start can all benefit from the QITs. There are two versions of each QIT - one for home-based/family child care programs and another for center-based programs. The resources in each QIT are geared toward the needs of the different types of programs.

#### Will I get training hours for completing the QITs?

The QITs are <u>not</u> training and training hours and certificates will not be given. The QITs guide individuals through creating action plans regarding the topic areas, but there are no submitted assignments or interaction with an instructor. The QITs are designed to support ongoing quality improvement efforts.

### Foundations of Universal Design (12 hours) – Online



In this training, participants will gain knowledge about the concept of Universal Design (UD) and how to

individualize for all children. Topics will include the philosophy of UD as a way of creating communities, the "what" and "how" of establishing

a community so that all children can benefit, and practicing simple modification and adaptation strategies to support children's success.

**Dates:** September 19<sup>th</sup> – October 17<sup>th</sup>

### Working with School Age Children and Youth (30 hours) - Online



This training covers the aspects of caring for school age children in out-of-school time setting. Topics covered include developing positive relationships, planning curriculum, health and safety, and adolescent development.

**Dates:** September 26<sup>th</sup> – December 12<sup>th</sup>

### Curriculum and Development for Preschool-Aged Children (30 hours) – Online

This training covers planning and implementing curriculum for all preschool children, regardless of their abilities.

### Maine's Early Learning and Development Standards Trainings



This training gives an overview of Maine's Early Learning and Development Standards (MELDS), including each Domain and ideas for integrating the content into a variety of settings. Each module introduces content and also highlights specific practices and skills designed to foster participants' abilities to utilize the MELDS independently once the training is complete. The training also has an intentional focus on principles for working with diverse populations and creating inclusive, developmentally appropriate learning environments.

### MELDS (30 hours) - Online

Modules begin on Wednesday mornings and end on Tuesday evenings. Participants who successfully complete all of the activities in the training will receive a certificate for 30 hours of training.

**Option #3**: October 10<sup>th</sup> – December 5<sup>th</sup>

#### Bridge to MELDS (15 hours) - Online

This is the 15-hour training that is meant for those practitioners who have successfully completed the 30-hour training "Maine's Early Learning Guidelines." Modules begin on Wednesday mornings and end on Tuesday evenings. Participants who successfully complete all of the activities in the training will receive a certificate for 15 hours of training.

### **Environments in Early Care and Education (30 hours) – Online**

This training describes the aspects of high-quality environments for children in all early childhood and out-of-school time settings, including both indoor and outdoor spaces. This training is appropriate for programs in homes, centers, Head Start, and schools.

Dates: September 26th - December 5th

### Positive Supports and Challenging Behavior (15 hours) – Online



This training provides a brief introduction to preventing and responding to situations of challenging behavior in early childhood programs. The goal of this training is to help you feel more confident when faced with challenging behaviors in your program.

### Fostering the Social Emotional Development of Young Children (30 hours) – Online

This training covers helping children develop social skills, self-confidence, and social emotional intelligence. Information included

covers building relationships, assessing the environment and curriculum for possible adaptations, and how to build internal controls and self-regulation skills in children. Consideration will also be given to how to prepare for and involve specialists if our interventions do not bear fruit.

### Caring for Infants, Toddlers, and Their Families (30 hours) – Online



This training covers the unique aspects of caring for infants and toddlers, including establishing relationships with families, understanding temperament, developing curriculum for infants

and toddlers, and creating welcoming environments.

#### Supporting Maine's Infants and Toddlers: Guidelines for Learning and Development (30 hours) – Online



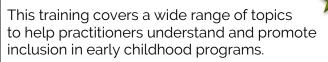
This training is designed to guide providers through the history, creation, and use of this publication, which outlines learning and development from birth to age three. The modules focus on the document and on developing understanding relationships.

#### Inclusive Child Care (30 hours) - Online



Dates: October 3<sup>rd</sup> - December 12<sup>th</sup>

### Teaching Adult Learners (18 hours) - Online

This training covers the aspects of teaching adult learners in both online and face-to-face settings. It covers basic theories related to working with adult learners and is appropriate for anyone in the role of delivering training or other professional development. It is required for those applying to become and MRTQ PDN Approved Trainer.

**Dates:** October 17<sup>th</sup> – November 28<sup>th</sup>

### Foundations in Health, Wellness, and Safety (18 hours) – Online



This training covers topics related to the health and safety aspects of early childhood programs, including reducing the spread of illness, nutrition and physical activity, environmental hazards, and working with children with special health care needs.

Please note that this is not the health and safety training required for programs serving families receiving Child Care Subsidy Program (CCSP) funds (see below for additional information).

**Dates:** October 17<sup>th</sup> - November 28<sup>th</sup>

#### Your Professional Development Portfolio (9 hours) – Online



This training is designed to provide resources and detailed information on how to create a professional portfolio that illustrates an early childhood or out-of-school time professional's knowledge, experience, and skills.

This training will be *required* for those submitting Maine Credential applications beginning on October 1, 2018.

Dates: October 24th - November 14th

### Linking Assessment to Curriculum in the Preschool Classroom (9 hours) - Online

This training was developed specifically to help teachers in center-based programs to link observations and assessments to curriculum planning and evaluation.

**Dates:** November 7<sup>th</sup> – 28<sup>th</sup>

#### Foundations of Inclusion: Relevant Laws, Featuring the American with Disabilities Act (ADA) (6 hours) – Online



This training will give an introduction to the history of disabilities and inclusion in the United States, as well as relevant laws governing the way inclusive services and supports are delivered.

Dates: November 28th - December 12th

### Partners in Caring: Families and Caregivers (12 hours) – Online



Children experience the best quality of care when families and caregivers are partners with the same goals for the child. This training covers information about families today,



roles and boundary-setting, and verbal/written communication to reduce potential areas of conflict between families and caregivers.

Dates: October 24th - November 21st

### Child Care Leadership Institute I: Foundation for Quality in Early Childhood and Out-of-School Time Programs (30 hours) – Hybrid



This training covers theory and legality as related to operating a center-based or out-of-school time program, the essential skills of staff hiring and supervision, family communication, professionalism, and self-survival within the art of program administration.

**Dates:** Begins online September 12<sup>th</sup>; face-to-face meetings on Fridays, September 21<sup>st</sup> and October 12<sup>th</sup>; online assignments due between inclass meetings

**Location**: Eastport Hall, Bangor

### Child Care Leadership Institute II: Leadership in Early Childhood Education Today (30 hours) – Hybrid



This training builds upon topics introduced in Child Care Leadership Institute I and is specifically oriented toward practitioners who are interested in expanding their leadership skills while working through the intricacies of directing a center-based or out-of-school time program.

**Dates:** Begins online October 24<sup>th</sup>; face-to-face meetings on Fridays, November 2<sup>nd</sup> & 30<sup>th</sup>; online assignments due between in-class meetings
