Maine's Early Learning and Development Standards (MELDS) Training Update

MRTQ PDN, in partnership with the Maine Department of Education (DOE), has developed two trainings on the MELDS: a 30-hour training that serves as an introduction to using the MELDS, and a 15-hour training called "Bridge to MELDS" that is meant for practitioners who have already completed the 30-hour training "Maine's Early Childhood Learning Guidelines." (Any practitioner is welcome to take the 30-hour training, whether or not they have taken the prior "Maine's Early Childhood Learning Guidelines" training.)

MRTQ PDN will be offering both trainings this spring. Details are included on page 5 of this newsletter and on the MRTQ PDN Statewide Training Calendar at: http://ecetrainingcalendar.muskie.usm.maine.edu.

The training "Maine's Early Childhood Learning Guidelines" will no longer be offered. If your program is enrolled with *Quality for ME*, Maine's quality rating and improvement system, and must renew your certificate in 2016, please contact MRTQ PDN at mrtq.contact@maine.edu. MRTQ PDN staff can help you determine which training is appropriate for you staff, depending on your program's Step with *Quality for ME*.

Please be assured that MRTQ PDN will work with the Department of Health and Human Service's Office of Child and Family Services to support a smooth transition for practitioners wishing to enroll in these new trainings, whether to fulfill a requirement for *Quality for ME* or for their own professional development.

Summer Scholarship Opportunities

MRTQ PDN is pleased to announce changes to the application process for practitioners seeking either a Child Development Associate (CDA) Credential through the Council for Early Childhood Professional Recognition OR one of the MRTQ PDN Credentials (Infant Toddler, Youth Development, Director, or Inclusion).

Applications for CDA Credential fees and MRTQ PDN Credential application fees will be accepted year-round. You must have completed 90 hours of MRTQ PDN Core Knowledge training in order to apply for these scholarships.

Applications for Maine colleges and universities, 081 and 282 certifications, or Praxis fees will be awarded by semester with application deadlines as follows:

- May Ist for Summer course work
- July 1st for Fall course work
- November 1st for Spring course work


Criteria for the award are:

- A practitioner in a child care center, family child care, before and after school program, Head Start, public preschool program, or nursery school.
- The nominee must be a member of the MRTQ Registry.
- A complete nomination form must be received by July 31st, 2016.

We would like to recognize classroom teachers and family child care providers who

are making a difference in the lives of children and their families in Maine. Complete nomination criteria are available on the MRTQ PDN website.

* The DHHS Districts are: York (District 1), Cumberland (District 2), Oxford, Franklin, and Androscoggin (District 3), Sagadahoc, Lincoln, Knox, and Waldo (District 4), Kennebec and Somerset (District 5), Penobscot and Piscataquis (District 6), Washington and Hancock (District 7), and Aroostook (District 8).

Your Professional Development Portfolio: The How, When, and Why (9 hours) – Online

This training is a brief exploration into how to create and utilize several of the portfolios found within the field of early childhood education. We will set the path towards a deeper understanding of a professional portfolio, how to create one, and why you might want to have one!

Option #1: March 16th – April 6th Option #2: April 27th – May 18th

Early Childhood Education: Theory to Practice (9 hours) – Online

This training covers the historical perspective of early childhood education in the U.S., major types of ECE programs, a survey of major theorists who have contributed to the field, and an overview of common terminology. (This training was formerly called "Introduction to Early Childhood Education.")

Dates: March 24th - April 16th

Caring for Infants, Toddlers, and Their Families (30 hours) – Online and Face-to-Face



This training covers a wide range of topics with the objective of helping early care and education practitioners develop a deeper understanding of high-quality environments for children. Participants will have opportunities to explore resources, share strategies and ideas, and consider ways to enhance the environments in which they work and play with children.

Online Dates: March 30th - June 8th

Face-to-Face Dates: Tuesdays, March 15th – May 17th;

6:00-9:00pm

Location: Educare Central Maine, Waterville

Linking Assessment to Curriculum in the Preschool Classroom (9 hours) - Online

This training is designed for practitioners working in child care centers to help increase knowledge and level of comfort with the process of assessment and curriculum planning in the preschool classroom.

Dates: March 16th - April 6th

Environments in Early Care and Education (30 hours) – Online

The objective of this training is to help early care and education practitioners develop a deeper understanding of high-quality environments for children. Every setting has unique benefits and challenges – participants will have opportunities to explore resources, share strategies and ideas, and consider ways to enhance the environments in which they work and play with children.

Dates: April 6th – June 15th

Foundations of Health, Wellness, and Safety (18 hours) – Online



Participants will be introduced to the importance of health, wellness, and safety through personal care routines, nutrition education, and environmental hazards that could impact the health of children and families.

Dates: March 30th – May 11th

Foundations of Universal Design and Individualizing (12 hours) – Hybrid and Face-to-Face



In this training, participants will gain knowledge about the concept of Universal Design (UD) and how to individualize for all children. Topics will include the philosophy of UD as a way of creating communities, the "what" and "how" of establishing a community so that all children can benefit, and practicing simple modification and adaptation strategies to support children's success.

Introduction to Infant Mental Health: Issues and Practice (18 hours) – Face-to-Face



This training covers topics concerning personality development, the balance between attachments systems and exploratory systems, developmental and environmental aspects, and influences on parent and child's sense of self and developing competencies.

Option #1: Saturday, April 23rd; 9:00am-3:30pm AND Wednesdays, April 27th – May 18th; 6:00-9:00pm

Location: Payson Smith Hall, USM Campus, Portland

Option #2: Thursday and Friday May 19th & 20th and

Teaching Adult Learners (18 hours) - Online

This training is for any professional working with adult learners. It will cover the topics of "who is the adult learner?" self-reflection on who the trainer is as an educator, and the role the trainer plays in present and future professional development of the adult learner. It will also examine the dynamics of online learning and training and explore the requirements for becoming a Maine Roads to Quality Approved Trainer.

Dates: April 13th - May 25th

Laying the Foundations for NAEYC Accreditation (27 hours) – Online

Do you have some questions about working toward accreditation, but you are not quite ready to commit to the accreditation process yet?

MRTQ PDN will be offering an online training to help prepare child care center directors and lead staff for the process of pursuing accreditation through the National Association for the Education of Young Children.

Dates: April 27th - June 29th

Supporting Maine's Infants and Toddlers: Guidelines for Learning and Development (30 hours) – Online



This training is designed to guide providers through the history, creation, and use of this publication, which outlines learning and development from birth to age three. The modules focus on the document and on developing understanding relationships.

Option #1: April 6th – June 1st Option #2: May 4th – June 29th

Foundations of Inclusion: Relevant Laws, Featuring the Americans with Disabilities Act (ADA) (6 hours) – Online



This training will give an introduction to the history of disabilities and inclusion in the United States as well as relevant laws governing the way inclusive services and supports are delivered. Participants will explore how belief and attitudes have historically influenced how services and supports are developed, as well as their own values and beliefs about disability and inclusion.

Dates: May 18th – June 1st

Pre-registration is required for all MRTQ PDN training.

Participants are expected to attend all in-class sessions and to complete all online assignments.

Maine's Early Learning and Development Standards (30 hours) – Online



This is the **NEW** training on the MELDS. (See the article on page I for more details about this training.)

Option #1: April 13th – June 8th
Option #2: April 20th – June 15th
Option #3: April 27th – June 22nd
Option #4: May 4th – June 29th

Bridge to MELDS (15 hours) - Online

This is the **NEW** training on the MELDS designed for practitioners who have completed the training "Maine's Early Childhood Learning Guidelines." (See the article on page I for more details about this training.)

Dates: "Bridge to MELDS" trainings will start WEEKLY on Wednesdays from April 13th through May 25th. PRE-REGISTRATION IS REQUIRED and class size is limited, so early registration is encouraged.

Collaborating with Others to Support Inclusion (12 hours) – Hybrid



Working as a team to support children with disabilities can sometimes be a challenge and we might wonder about the right things to say and do. This training will cover strategies for collaborating with families and other professionals, teambuilding strategies, and conflict resolution skills.

Dates: May 4th – 25th; face-to-face classes Wednesdays 5/11 and 5/25; 6:00-9:00pm; online assignments due

between class sessions

Location: Windham Public Library, Windham

Child Care Leadership Institute II: Leadership in Early Childhood Education Today (30 hours) – Hybrid



Leadership II builds on the concepts from Leadership I, focusing on building leadership skills, supervision, communication, and organizational climate.

Dates: April 27th – May 20th; face-to-face classes on Fridays, 5/6 and 5/20; 9:00am-4:00pm; online assignments due between class sessions

Location: Waterville

Partners in Caring: Families and Caregivers (12 hours) – Online



Children experience the best quality of care when parent(s), family, and caregivers are partners with the same goals for the child. This training will offer caregivers information about families today – varieties, characteristics, stresses, challenges, and trends.

Dates: May 25th - June 22nd

Child Care Leadership Institute III: Transforming Leaders and Programs (30 hours) – Hybrid



This training builds upon topics introduced in Child Care Leadership Institutes I and II and is specifically oriented toward early childhood practitioners who are interested in expanding their leadership skills and becoming an advocate for young children and their families.

Dates: June 15th – July 15th; face-to-face classes on Fridays, 6/24 and 7/15; 9:00am-3:30pm; online assignments due between class sessions

Location: Waterville

Stress Happens: Distress or Eustress – Which Will You Choose? (6 hours) – Online

Stress can be all around us – as individuals and professionals. This 6-hour training is a brief journey to explore and define those stressors and how to manage the stress in our lives.

Dates: June 8th - 22nd

Teambuilding with Staff: The Collective Wisdom of Teams (6 hours) - Online

This training will allow staff to learn how to best work as a team. Participants will explore the definition of a team, as well as team basics.


