MRTQ Wants to Recognize Exceptional Educators!

At Symposium 2015 on October 24th, MRTQ will present the **Marcia Lovell Award** to up to eight individual teachers from around Maine who exemplify the late Marcia Lovell's ideal that all children are included in high-quality, inclusive early childhood settings. MRTQ is inviting the public to nominate exceptional educators



for this award. The MRTQ Advisory Council will review the nominations and select the winners this summer.

MRTQ is seeking nominations for educators who work in early childhood or school age programs, including family child care, center-based care, school age programs, public preschool, or Head Start. Nominations should include detailed information about how the educator exemplifies at least one of the following ideals:

- Advocate for better lives for children;
- Support the inclusion of children at-risk and those with special needs or disabilities in high-quality early childhood settings;
- Believe in the importance of including the arts in early childhood.

Quality for ME Revision Project Update

The Quality for ME Revision project has completed the face-to-face focus groups with both parents and practitioners in all of the eight DHHS state regions. Additionally, parents and providers were invited to share feedback through online surveys.



Along with the focus group and survey input, the project assigned a work group to represent a variety of settings, including family child care, center-based programs, before and after school programs, public preschool, and Head Start to review the current standards and make recommendation for changes. These

recommendations have been reviewed and will be considered by the *Quality for ME* Advisory Committee for further discussion and recommendations to be included in the final report, due by June 30, 2015.

The project staff would like to thank everyone who replied to the online survey, participated in local focus groups, and served on the work groups and Advisory Committee. This work has been highly influenced by your participation and will represent the best thinking from the Maine early care and education community.

Inclusion Credential

Stepping Up with Quality for ME for Child Care Centers (12 hours) – Online

This online training is intended to guide programs through the requirements of Maine's quality rating and improvement system, Quality for ME. This training is designed for CENTER-BASED PROGRAMS working to move from a Step I to a Step 2 or from Step 2 to Step 3.

Dates: July 15th – September 9th

Child Care Leadership Institute II: Leadership in Early Childhood Education Today (30 hours) – Hybrid



This training builds upon topics introduced in Child Care Leadership Institute I and is specifically oriented toward early childhood practitioners who are interested in expanding their leadership skills as they work through the intricacies of directing a child care center. The institute will concentrate on the issues of leadership, supervision, communication, and organizational climate. This institute is designed to guide an established center director in assessment and refinement of leadership style, facilitative work with staff teams, and continued growth in leadership abilities.

Dates: June 17th – July 15th; face-to-face classes on Fridays, 6/26 and 7/10; 9:00am-3:30pm; online assignments due between class sessions

Foundations of Universal Design and Individualizing (12 hours) – Hybrid

In this training, participants will gain knowledge about the concept of Universal Design (UD) and how to individualize for all children. Topics will include the philosophy of UD as a way of creating communities, the "what" and "how" of establishing a community so that all children can benefit, and practicing simple modification and adaptation strategies to support children's success.

Partners in Caring: Families and Caregivers (12 hours) – Online



Children experience the best quality of care when parent(s), family, and caregivers are partners with the same goals for the child. This training will offer caregivers information about families today – varieties, characteristics, stresses, challenges, and trends.

Teambuilding with Staff: The Collective Wisdom of Teams (6 hours) – Face-to-Face

This training will allow staff to learn how to best work as a team. Participants will explore the definition of a team, as well as team basics.

Your Professional Development Portfolio: The How, When, and Why (9 hours) – Face-to-Face



This training is a brief exploration into how to create and utilize several of the portfolios found within the field of early childhood education. We will set the path towards a deeper understanding of a professional portfolio, how to create one, and why you might want to have one!

Early Childhood Education: Theory to Practice (9 hours) – Online

This training covers the historical perspective of early childhood education in the U.S., major types of ECE programs, a survey of major theorists who have contributed to the field, and an overview of common terminology. (This training was formerly called "Introduction to Early Childhood Education.")

Dates: July 22nd – August 12th

Stress Happens: Distress or Eustress – Which Will You Choose? (6 hours) – Online

Stress can be all around us – as individuals and professionals. This 6-hour training is a brief journey to explore and define those stressors and how to manage the stress in our lives.

Dates: July 22nd – August 5th

Please Note:

- Registration closes two business days before the start of the training to allow MRTQ and the trainer adequate preparation time. Many trainings fill quickly, so we advise you to register early!
- MRTQ is sometimes able to add additional training based on demand; if you try to register for a training that is full, we highly recommend that you place your name on the waiting list. If a second session is added, those on the waiting list receive priority registration!

Foundations of Health, Wellness, and Safety (18 hours) – Online



Participants will be introduced to the importance of health, wellness, and safety through personal care routines, nutrition education, and environmental hazards that could impact the health of children and families.

Dates: August 19th – September 30th

Positive Supports and Challenging Behavior (15 hours) – Hybrid

This training provides a brief introduction to the many facets of preventing and responding to situations of challenging behavior in early childhood programs. This hands-on training will involve dialogue with your peers and the facilitators and the creation of templates and tools that you can bring back to your program for continued exploration. The goal of this training is to help you feel more confident and competent when

faced with challenging behaviors in your program.

Dates: September 9th – 26th, face-to-face sessions on Wednesday, 9/16; 6:00-9:00pm AND Saturday, 9/26; 9:00am-3:30pm; online assignments due between class sessions

Location: Center for Community Inclusion and Disability Studies, Augusta

Teaching Adult Learners (18 hours) - Online

This training is for any professional working with adult learners. It will cover the topics of understanding the adult learner, self-reflection on who the trainer is as an educator, and the role the trainer plays in present and future professional development of the adult learner. It will also examine the dynamics of online learning and training and explore the requirements for becoming a Maine Roads to Quality Approved Trainer.

Caring for Infants, Toddlers, and Their Families (30 hours) – Face-to-Face



This training covers a wide range of topics with the objective of helping early care and education practitioners develop a deeper understanding of highquality environments for children. Through this training participants will have opportunities to explore resources, share strategies and ideas, and consider ways to enhance the environments in which they work and play with children.

The Registry Goes Paperless!

To become more efficient and ecofriendly, MRTQ will be digitizing all documents.



What does this mean to you? When

possible, please scan and email your documents to <u>mrtq-registry@usm.maine.edu</u>. You can still send paper copies of documents. Upon receipt, they will be digitized and the paper copies will be destroyed. MRTQ will not retain copies of verified trainings. If submitting documents through the mail, keep a copy for your records.

Please do not send original copies, as we will not be able to return them to you. We generally discourage faxing your documents to us, as there seems to be a much higher rate of the faxed documents never reaching us, and some documents do not fax well and are impossible to read. Thank you for your assistance in helping us become paperless!

Maine Director Credential Recognized as an Approved Administrator Credential

In April, MRTQ received notice from the National Association for the Education of Young Children (NAEYC) that the Maine

Director Credential is now an approved Administrator Credential.
